VIVA GOLD CORP CLOSES C\$3.0 MILLION PRIVATE PLACEMENT

VANCOUVER, BC – June 23, 2020 – Viva Gold Corp. (**TSX-Venture: VAU; OTCBB: VAUCF**) (the "**Company**" or "Viva") is pleased to announce that it has completed the non-brokered private placement (the "Offering") described in its news release of June 4, 2020. In connection with the closing of the Offering, the Company issued an aggregate of 12,060,380 units (the "Units") at a price of CDN\$0.25 per Unit for gross proceeds of CDN\$3,007,500. Each Unit consists of one common share in the capital of the Company (a "Share") and one-half of one non-transferable common share purchase warrant (each whole common share purchase warrant, a "Warrant"). Each whole Warrant is exercisable to acquire one Share at an exercise price of CDN\$0.30 per Share until June 22, 2023 which is 36 months from the date of issuance.

Insiders of the Company acquired an aggregate of 5,020,000 Units in the Offering, which participation constituted a "related party transaction" as defined under Multilateral Instrument 61-101 Protection of Minority Security Holders in Special Transactions ("MI 61-101"). Such participation is exempt from the formal valuation and minority shareholder approval requirements of MI 61-101 as neither the fair market value of the Units acquired by the insiders, nor the consideration for the Units paid by such insiders, exceed 25% of the Company's market capitalization. As required by MI 61-101, the Company advises that it expects to file a material change report relating to the Offering less than 21 days before completion of the Offering, which is necessary to complete the Offering in an expeditious manner and is reasonable in the circumstances.

Viva plans to allocate the gross proceeds of the Offering to: (i) drilling; (ii) technical studies; environmental/permitting studies; and (iii) exploration on Viva Gold's Tonopah Project; and (iv) general working capital.

The Company will pay aggregate finder's fees of CDN\$165,725.00, payable in either cash or shares, in connection with subscriptions from subscribers introduced to the Offering by Fieldhouse Capital Management Inc, Canaccord Genuity Corp, Leede Jones Gable Inc, PI Financial Corp, Haywood Securities Inc and Mackie Research Capital Corporation.

The Offering remains subject to final approval of the TSX Venture Exchange.

The securities issued under the Offering, and any Shares that may be issuable on exercise of any such securities, will be subject to a statutory hold period expiring four months and one day from the date of issuance of such securities.

Mars is at arm's length to Viva and has no other relationship with Viva, except pursuant to the Agreement.
